



ACI 3000 PREMIUM 70% PVDF COATING SYSTEM LIMITED WARRANTY

ACI Building Systems, LLC warrants that its ACI 3000 paint system, when exposed to normal exterior weathering conditions:

1. Will Not crack, check, or peel (lose adhesion) for a period of twenty (20) years. This does not include minute fracturing which may occur during the fabrication of building parts such as crazing or slight cracking.
2. Sidewall Panels:
 - a. Will Not chalk in excess of ASTM D-4214 method D659 number 8 rating at any time for twenty (20) years from date of shipment.
 - b. Will Not change color more than five (5) Hunter ΔE units as determined by ASTM method D-2244. Color change shall be measured on an exposed painted surface that has been cleaned of surface soils and chalk, and the corresponding values measured on the original or unexposed painted surface. It is understood that fading or color change may not be uniform if the surfaces are not equally exposed to the sun and elements.
3. Roofing Panels:
 - a. Will Not chalk in excess of ASTM D-4214 method D659 number 8 rating at any time for twenty (20) years from date of shipment.
 - b. Will Not change color more than five (5) Hunter ΔE units as determined by ASTM method D-2244. Color change shall be measured on an exposed painted surface that has been cleaned of surface soils and chalk, and the corresponding values measured on the original or unexposed painted surface. It is understood that fading or color change may not be uniform if the surfaces are not equally exposed to the sun and elements.

TERMS AND LIMITATIONS

If the ACI 3000 paint system fails to comply with our limited warranty, ACI shall, at its option, pay for refinishing or replacing the metal coated with the product claimed to be defective. In no event shall ACI's liability exceed the lesser of the cost of replacing the coated metal or refinishing the metal on site. ACI **WILL NOT** be liable for any incidental or consequential damages. In order for the warranty to be in effect, you must first notify us in writing of the failure within thirty days of the discovery of such problem and provide documentation we may require. If we repaint, we will use normal field painting practices. This warranty also applies to the part we repainted, repaired, or replaced, but only for the unexpired portion of the warranty period applicable to the original part. Our **Limited Warranty Does Not Apply** to circumstances which we do not control, including, but not limited to, fire or physical damage, unusual harmful fumes, foreign substances in the atmosphere, direct salt spray, damage due to abrasive or chemical cleaners, and defects in the base metal. Mishandled Products, e.g., **ANY PRODUCT WHICH HAS BEEN ABUSED, ALTERED, MODIFIED, USED IN A MANNER NOT ORIGINALLY INTENDED, OR STORED CONTRARY TO OUR INSTRUCTIONS. ACI IS NOT RESPONSIBLE FOR WATER DAMAGE OF PREPAINTED SHEETS PRIOR TO ERECTION OF MATERIALS.** This also includes
a) damage to the product occasioned by condensation attributable to improper handling, shipping, processing, and/or installation;
b) damage due to failure of the substrate.

This warranty will only apply to prepainted metal shipped within the Continental United States. Except for this warranty, ACI makes **NO WARRANTY OR GUARANTEE EXPRESS OR IMPLIED WITH RESPECT TO THE ACI 3000 COATING SYSTEM. IMPLIED WARRANTIES FOR FITNESS AND MERCHANTABILITY ARE EXCLUDED.** This is our complete warranty. It sets out all of our obligations regarding the ACI 3000 coating system. It is only for your benefit and is **NOT ASSIGNABLE OR TRANSFERABLE.** It cannot be changed by such things as your purchase order form or our acceptance forms. But it can be altered only if ACI agrees in writing.
